

Do NOT Plant within 2 ft of Wall OR Driveway

---

All plantings of anything other than annual flowers must be approved by the Landscape Committee/Board of Directors, regardless of location, including "freshening" of current planting bed areas. Nothing may be planted or placed in common areas without written permission from the Board of Directors. "Florida Friendly" plantings are encouraged. All plantings of trees, plants/bushes must be a minimum of two feet from all walls and driveways. A sketch/diagram showing planting area dimensions/location and identification of plants must accompany the Landscape Request Form. (see Pages 4-5 for Sample.)

**Not allowed to be planted:**


1. Anything considered an invasive species or "aggressive spreader".
2. Nothing with thorns, including but not limited to cactus, holly, bougainvillea.
3. Rhizomes including but not limited to bamboo, ginger, Japanese knotweed.
4. Fruit trees.
5. Viney/climbing/trailing plants including but not limited to morning glory, philodendron, pothos, trumpet vine.

**Note:** Any of the above previously planted in Oak Forest that become a problem will be removed by the Board of Directors.


